-Hunter is responsible for taxidermy, meat processing, and transporting costs.

-For the baited bear hunts the policy is that drawing blood counts as a kill. Since you have 2 bear licenses you can kill or wound a maximum of 2 bears total. That means that if you draw blood on 2 animals and we can't find either one of them then your hunt for that species is over. Of course we always make every effort to recover any wounded animals and we don't encourage unethical shots.

I further accept and assume all risks of personal injury or death or loss or damage to property while participating in the said guided excursion and that I do so voluntarily.

I acknowledge that this Agreement and any rights, duties, and obligations as between the parties to this Agreement shall be governed solely in accordance with the laws of the Province of Alberta of Canada in which these events occur and no other jurisdiction; and any litigation involving the parties to this Agreement shall be brought solely within the Province of Alberta of Canada and shall be within the exclusive jurisdiction of their Courts.

I acknowledge that in entering this Agreement, I am not relying on any oral or written representations or statements made by the Guide Outfitter with respect to the safety of wilderness travel.
